CONDITIONS OF ENTRY (PLEASE READ CAREFULLY)

THIS SHOW WILL BE CONDUCTED UNDER THE ARABIAN HORSE SOCIETY CURRENT RULE BOOK AND THE FOLLOWING SA ARABS Inc RULES

1. The lodging of any entry shall bind the exhibitor to the conditions of entry and the regulations set out here in and the signature of any exhibitor on the entry form shall constitute acceptance of these conditions
2. SA ARABS Inc Committee shall have the power without giving reason to:
 - a) Reject or cancel any entry at any time
 - b) Alter the time of the scheduled event or class starting time
 - c) Remove any exhibitor from the showground for displaying abuse towards their horse.
3. Rings will not be held up for competitors who have clashing classes. However every endeavour will be made to ensure that clashes do not occur.
4. **SA ARABS Inc Committee reserve the right to combine any classes**
5. Stallions and colts will not be permitted to be handled, ridden, or driven by any person under 18yrs whilst on the show grounds.
6. **All exhibits**, including foals, **must be registered** with the AHSA and the registration number **must** be quoted on the entry form. A photo copy of the registration certificate **MUST** accompany entries. Pending registrations are not acceptable. Ages of the horses/ponies are referenced to the 1st August convention.
7. All horses, excluding foals, must be able to be identified by their brands and or markings in accordance with the Certification of Registration issued by the Society. Change of coat colour or adding white markings is prohibited and may result in disqualification
8. SA ARABS Inc shall not be held responsible for loss of or damage or injury occasioned to any exhibitor or to the property of any exhibitor for any cause what so ever.
9. The exhibitor and exhibits enter entirely at their own risk. In any case of an exhibit, whilst on the showgrounds, causing or being the cause of injury or damage to any other exhibitor or exhibit, OR to the person or property of ANY member of SA ARABS Inc or its officers, the general public, each owner of such exhibit shall indemnify SA ARABS Inc, its officers, officials and members from and against all damages, costs, claims, expenses or liabilities incurred with such incident. The exhibitor shall be liable to SA ARABS Inc its officers, officials and members for any damage or loss occasioned to any of them by the exhibit or exhibitors or agents.
10. SA Arabs Inc has a Risk Management Policy (incl Hot weather policy & Child Safe Policy) and all exhibitors are encouraged to read this document available at :-

11. A horse that in the opinion of the judge/steward or committee has been subject to abuse or shows whip marks will not be judged.
12. **PROTESTS:** The following persons may lodge a protest - Competitors or Exhibitors in the disputed Class or any Show Official. The protest must be lodged within ONE HOUR of the completion of the event or class. Protests must be accompanied by \$50.00 cash, refundable if the protest is upheld.
13. **DISPUTES COMMITTEE:** The Disputes Committee will be made up of the following:
 - a) One Committee Member.
 - b) The Show Manager and/or Ring Master.
 - c) One Competitor.No member of this Committee may hear a protest in a Section of the Show in which he/she is exhibiting or competing. The Judge of the Section concerned may be consulted. The decision of the Committee is final and binding.
14. Exhibitors will not be allowed to enter the ring once judging has commenced.
15. The Judge's decision is final.
16. The age of Junior competitors will be calculated from the first day of the show. Copy of Birth Certificate may be requested.

17. INSURANCE

All Exhibitors / handlers / grooms/ riders who are Members of the Arabian Horse Society of Australia (or any of its affiliates) must complete the AHSA Liability Declaration. A copy of the current Membership Card must also be submitted with entries.

All Exhibitors handlers / grooms/ riders who **are not members** of the AHSA (or any of its Affiliates) must complete the Registered Participant Agreement and pay the “Day Insurance Fee “ of \$10.

NO ENTRIES WILL BE ACCEPTED IF PROOF OF MEMBERSHIP IS NOT PROVIDED OR DAY INSURANCE IS NOT PAID. ALL PERSONS WHO WILL BE HANDLING HORSES MUST HAVE INSURANCE COVERAGE

RANDOM SWABBING MAY TAKE PLACE AT THIS EVENT

JAHAHN RAZADAH/JAHAHN EZREM BEY VERSATILITY AWARD –

For high point Senior horse, entry is free. An entry form must be completed and handed to Show Secretary at the end of the day for collation of results. The classes to be included are Championship Led Classes, Championship ridden classes, Costume, Stockhorse, English Pleasure, Western. No OTHER classes to be included. Open to Purebred and Derivative Horses.

CRABBET RELATED CLASSES – Purebred Arabians only with more than 60% Crabbet Blood. Proof of Crabbet breeding to be sent with entry form. (If known, highlight Crabbet relatives on copy of pedigree.

BEST SOUTH AUSTRALIAN BRED SWEEPSTAKES – to be eligible for Best South Australian bred Sweepstake Classes, the exhibit must have been foaled in SA and have been owned by a permanent SA resident at the time of foaling. Placings will be awarded to 3rd place. The classes are run as Sweepstakes – all entry money is pooled and awarded to the three placegetters in each class on the basis of; First place 50%, Second place 30% Third place 20%. Winners of the Best South Australian Bred classes are not eligible for Supreme awards

NOVICE HACK

is a hack which has not won a first place in an Open Hack Class, or Championship (Novice or Open) at any Show at the closing date of entry for the grading of that event. To be able to perform at Maiden level. Walk, trot and canter with simple change of lead through the trot and transitions of pace. Lengthening of stride at the trot may be asked. To be ridden in a snaffle bit with Dropped/Hanoverian or cavesson nose band.

ENDURANCE CLASSES

Horses must be in possession of an official Yellow Australian Endurance Riders Association (AERA) Endurance horse Log Book. At time of entry, each competitor must provide the following:

- a. Copies of the two identification pages from the front of the Horse's Log Book.
- b. A copy of the horse's current AERA Registration status (either annual or life).

Equipment and dress must be appropriate and not detrimental to endurance riding. Rider's attire should present a smart athletic image and be neat and tidy. Riders must wear an equestrian standard helmet that complies with the current equestrian standard in Australia, the USA or Europe current at the time of manufacture Please note that warranty is only five years from that date. NOTE: Bicycle helmets are not permitted.

Whips and spurs are not permitted, nor any apparatus which might affect the performance of the horse

In consideration for being permitted to participate in any way in horse sport activities and in particular this event, I, the undersigned, understand, acknowledge and accept that:

Horse sports are a dangerous recreational activity and horses can act in a sudden and unpredictable (changeable) way, especially if frightened or hurt.

There is a significant risk that serious **INJURY** or **DEATH** may result from horse sport activities and in particular this event.

I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the proprietors of the Arabian Horse Society of Australia Ltd and/or the event organiser (hereafter referred to as the "Releasees") or others and I voluntarily PARTICIPATE at my OWN RISK and assume sole responsibility for any injury, death or property damage I may suffer that arises from my participation in horse sport activities.

I understand and acknowledge the dangers associated with the consumption of alcohol or any mind altering drugs before and during the activity and I take full responsibility for any injury, loss or damage associated with their consumption. I agree not to drink alcohol or take drugs prohibited by law before or during this event.

I agree to follow the directions of any event organiser or official and that any misconduct or refusal by me to follow any direction of any organiser or official can result in the **CANCELLATION** of my participation in the event and my immediate removal from my horse **NO MATTER** where that may occur. I further agree to abide by the Rules and Conditions of this show and the official Rule Book of the Arabian Horse Society of Australia. I understand that any such non-compliance may result in injury, death and/or permanent disability and I agree to indemnify the Releasees against all claims made by any person as a result of my failure to comply.

I agree to wear a helmet at all times whilst riding and agree that I am solely responsible for ensuring that I wear a suitable helmet at all times while riding and take sole responsibility for my actions.

I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release and hold harmless and agree not to sue the proprietors of the Arabian Horse Society of Australia Ltd and/or the event organiser, their officers, officials, volunteers, coaches, agents and/or employees, other participants, sponsoring agencies, sponsors, state bodies, affiliated clubs and if applicable, owners and lessors of premises used to conduct the activities (all of whom are referred to as "Releasees") with respect to any and all injury, disability, death, or loss or damage to person or property, whether caused by the negligence of the releasees or otherwise.

I understand that due to diseases such as equine influenza, the Department of Primary Industries, or other state or commonwealth government bodies may restrict or prevent the movement of horses, vehicles and personnel for a time period, otherwise known as a "standstill". I acknowledge that a standstill is a risk of competing and agree to pay any costs or expenses incurred by any person or organisation for and on behalf of my horse(s) as a result of the standstill.

Effect of this Document - I have had sufficient opportunity to read this release of liability and assumption of risk agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without inducement of any kind. I understand that my signature to this document constitutes a complete and unconditional release of all liability of the Releasees, to the greatest extent allowed by law in the event of me and/or the children under my care, suffering injury or death.
